It's Time for Officer Elections

ETSA holds elections for officers every two years, so 2015 is the year to again elect officers.

The nominating committee was charged with the task of seeking a slate of officers to present on the ballot. The nominating committee presented one name for each office at the third quarter general meeting and the floor was open to accept other nominations. No other nominations were made so the names presented by the nominating committee were approved by members present to appear on the ballot.

Please note that ballots are included for adult members only. Junior members do not have voting privileges in officer elections.

Pete Hitch was nominated for the office of president. Pete is best known as part of the team (along with Heath Hughes) who run the successful Hickory Lane Farms in Maryville, TN. Heath and Pete work a number of competitive American Saddlebreds.

(Note: Normally the vice president moves into the president's position, however, Lisa Catron is not able to step into the position so a new president is being elected.)

Kathryn Moore is on the ballot for the position of vice president. Kathryn and Lisa Catron teamed up for years to operate Bridle Path Farm. Kathryn is very active with the Ridin' High Therapeutic Riding Program and has been a part of ETSA since the beginning.

Heather Jones was nominated for the position of treasurer. Heather has served as vice president and president of ETSA in past years and currently holds the office of treasurer. Heather teaches art at Greeneville High School and has also been a member of ETSA since the beginning days.

Dianna Pearson was nominated for secretary. She currently serves as secretary and has served in that capacity several times. She also serves as registrar for the American Saddlebred Horse Breeder' Futurity of Tennessee. She designed and maintains ETSA's web site. Dianna has a background in photography and graphic design and like Kathryn and Heather, has been a member of ETSA since the organizations inception.
